    - 4. Fish stocking was partially paid by member donations, DNR is stocking walleye every other year and will do again in 2024

  - b) We have exactly 15 candidates and a voice vote was completed by candidate
- 4. Voting Mike Garvey makes a motion to vote in the slate of 15 candidates as presented. Seconded by Dan McDevitt. Accepted by the membership.
- 5. All in favor of accepting all candidates as presented for a 3 year term. accepted unanimously

## BY-LAWS AMENDMENT - Article IV, Section 1 (Voting) – Amendment 1 Passed

Amendment Option 1 ("one vote"): "Each member shall be entitled to one (1) vote, and in case any lot is owned by multiple owners by the entireties (or is being purchased in such manner on land contract) the owners, collectively, shall only be entitled to one (1) vote. In no event shall one person have more than one (1) vote, regardless of the number of lots or other property within the boundaries of this corporation owned by such person.

Amendment Option 2 ("two votes"): "Each member shall be entitled to one (1) vote, and in case any lot is owned by multiple owners by the entireties (or is being purchased in such manner on land contract) the owners shall each be entitled to one (1) vote with a maximum of two votes collectively. In no event shall one person have more than one (1) vote, and multiple owners may not have more than two (2) votes collectively, regardless of the number of lots or other property within the boundaries of this corporation owned by such person(s)."

To replace the current by-law: "Each member shall be entitled to one (1) vote, and in case any lot is owned by husband and wife by the entireties (or is being purchased in such manner on land contract) the husband and wife shall each be entitled to one (1) vote. In no event shall one person have more than one (1) vote, regardless of the number of lots or other property within the boundaries of this corporation owned by such person."
