President's Corner



What a great summer!!

July was steamy, August was moderate, and September (as I write this) is turning out to be one of the best I can remember!

As many of you know, I have a lot of passion for re-establishing natural shorelines around Gravel Lake. I thank my wife, Missy, for lighting the fire and our whole-lake study by Progressive AE for affirming the need for the change. Establishing a natural shoreline can prevent erosion, filter nutrients before they get to the lake, and provide crucial shoreline habitat. While I understand that this is still a new idea for many and could be difficult for some owners to execute, I want to acknowledge the growing efforts I'm seeing around the lake. It goes without saying that the Mastersons on Huff's Landing, and the Andrews on Streeter have fully natural shorelines that represent what the lake looked like before human development. Beyond that, quite a few of you with rip rap (stones) are offsetting that with lake-friendly plantings: Fallon, Carlos, and Rockwell on Chamberlin, Moore and Oltolski on Willow, Bergenham on Winkler, Friend on Lewis, Gordon/Bogner on Streeter, and Fazzini (a particularly good-looking example!) on Gebhard.

I've pushed the DNR to lead by example at the public access: more plants in the rip rap will help runoff from the lot AND stabilize the shoreline to prevent the erosion issues we've had in the past. Additionally, leaving your shoreline with an un-mowed buffer strip is a great, low-maintenance option where you can allow native shoreline plants to reestablish themselves naturally: Gordon on Gebhard, Kurtyak (great example of a deeper buffer AND the use of a variety of native plants; nice martin houses too!) on Gebhard, between Moore's and Osborne's (looks good despite low/no maintenance and serves as valuable runoff filter for the neighborhood) on Willow, Garrison/Mateyack and Kapercev on Idle Ease, North Ct. on Streeter, Zwartz, Beebe/Bainbridge, and Sundar on Chamberlain, Rousell and van Schoyck on Lewis, Deren on Huff's Landing, Davis on Sandy (channelside), LaMonte on Winkler, and Kotal (an EXPANSIVE buffer!) on Winkler.

How about even leaving just a bit of your shoreline natural? McDevitt/Rusthoven on Huff's Landing, McGreal/Morkunas on Sandy, and Meltons on Chamberlin appear to be doing that. In most of the cases there's an opportunity to make your offset or buffer a bit deeper; adding more width between the water and your mowed space will strengthen your shoreline and increase its ability to filter. Finally, most impressive is the lakeside garden that the Howells (Huff's Landing) have established; it's good-looking, has produce (!), and is a very functional buffer and habitat at the lake shore. Great work!

Did I miss your effort? Please let me know about it! Do you have pictures of your progress? Please share them with me and on the Gravel Lake Association Community Facebook group. Do you have questions or need suggestions? I've already had several in-depth discussions with owners who would like to prevent erosion and/or establish a good-looking lakeshore garden.

Is It Time For A Boat Wash?

The state of Michigan is finally starting to catch on. They can see the increasing threat of invasive species to our inland lakes. As of March 21, 2019 it is the law that all boats leaving a lake be cleaned and dried, all drain plugs pulled, and any bait disposed of. Through our special assessment district, Gravel Lakers pay for the removal and control of aquatic invasive species every year. Most of the time we are not the ones bringing them here but we have to manage them or face the consequences. More invasive species enter the state and move from lake to lake all the time, some of them with the potential to cause great harm to our ecosystem and property.

The Gravel Lake Association has started to engage boaters that use the public access, making sure they understand how to stop the spread. Last year we participated in a Landing Blitz movement designed to talk with boaters over the 4th of July holiday season and provide them with an easy way to remember what they need to do; Clean, Drain, Dry. This year, for the second time, we had a mobile boat wash come to our public access. The two staff members from Michigan State University's Mobile Boat Wash Team spoke with all our guest boaters about Clean, Drain, Dry and offered to wash their boats for free after using the lake. They spoke with many people and were able to wash a few boats, but your GLA wants to do even more.

At the Michigan Lakes & Streams conference in May we were able to see a demonstration from a company that makes a boat wash system that doesn't use any water. The system by a company called CD3 (Clean, Drain, Dry, Dispose) uses different brushes, a vacuum, and a tank to collect the plant material from boats. The system reports on how often it's used, if any part of the machine needs maintenance, and if the tank needs to be emptied. In the past we thought

a boat wash needed to have water and sewer hook-ups, making it a much more expensive project. With this system, we can provide a way for boaters to Clean, Drain, Dry (are you seeing a pattern here?) helping them comply with the law and reduce the spread of invasive species to our lake and others. We are already paying to maintain the invasive species in our lake. It's time we take it to the next level and contribute to the fight against their spread. We want to do this for the love of our lake and also for the future of all Michigan lakes.

GLA Membership Dues

At our June membership meeting and picnic, annual membership dues were increased to \$50.00 (from \$35.00) effective January 1, 2020. This vote, motioned and seconded by general members, passed by a wide margin with only two votes against it. The vote followed discussion of the following topics: income vs. expenses, legal defense fund, and a boat wash for the public access.

While the Gravel Lake Association does have what some may consider an ample funds balance, it does obscure the fact that annual expenses far exceed income from membership dues. Newsletter production, the annual picnic, 4th of July activities, and fish stocking are just a few popular items that would not be covered by dues income alone. It is our successful (and labor intensive) fundraising activities that allow us to have a comfortable fund balance and enable us pursue high-dollar efforts like our whole-lake study (~\$20K) with expedience. Though fundraising income may seem sure to some, it is precarious. Some of you may remember the Gravel Lake Socials we used to host that were solid fundraisers for us. Eventually, that event lost popularity and an income source was lost. Currently, our Poker Run is the best fundraiser the GLA has ever done, but it has been at risk of cancellation (due to lack of dock hosts) for the last two years and we can only hope it maintains its popularity. Even our Gravel Lake gear sales are just now profitable (vs. being a "public service" in years past) thanks to the re-doubled efforts of our very passionate fundraising committee (nice work Carlie, Janice, Jen, and Suzanne!).

Regarding legal issues, we've learned from other lake associations via Michigan Lakes & Streams Association that Gravel Lake has simply been lucky not to suffer an external whole-lake threat. Examples include DNR purchase/expansion of public access sites to allow greater lake usage, industrial pig farming very close to a lake (CA-FOS) which poses a pollution threat, and subdivision development adjacent to lake posing access and crowding issues just to name a few. The GLA Board of Trustees saw a compelling presentation on this topic and has interest in establishing a fund or earmarking funds should the need for legal representation become necessary. The recommendation received was having \$20K "ready" for such purposes. The GLA Board of Trustees has not made a final decision on the nature of such a fund.

Finally, as a membership we discussed the possibility of a boat wash at our public access. As many understand, the public access (DNR site) is our single largest source of Aquatic Invasive Species (AIS...e.g. eurasian watermilfoil, starry stonewort, zebra mussels, etc.). Refer to our feature article on this topic (on page 4) for more details. No decisions have been made on a boat wash, but it's another example of a funding need for Gravel Lake.

Many of the aforementioned topics are new to Gravel Lake. They represent a proactive mindset rather than a reactive one. They also present a bigger picture, longer term vision for Gravel Lake. We can boast high water quality, strong home values, and a truly unique community with excellent social activities. That said, the GLA must be open-minded, open-eyed, and at least somewhat vigilant in protecting this very special place. With all modesty, I dare to believe that the unprompted dues increase vote is an indication we're moving in the right direction.

1. Clean any visible mud, plants, or fish off of your boat by rinsing it off with clean water.
2. Drain all water holding compartments (including live wells, bait wells, and bilge areas).
3. Dry boats and trailers before entering another body of water.

The Clean Boats, Clean Water Initiative is a way to educate people, state-wide, about how invasive species spread. Just like any other lake, ours is vulnerable to these invasive species. (Anyone else remember how fun it was when Eurasian Watermilfoil had us stopping our boats to clean the prop a quarter of the way around the lake?)

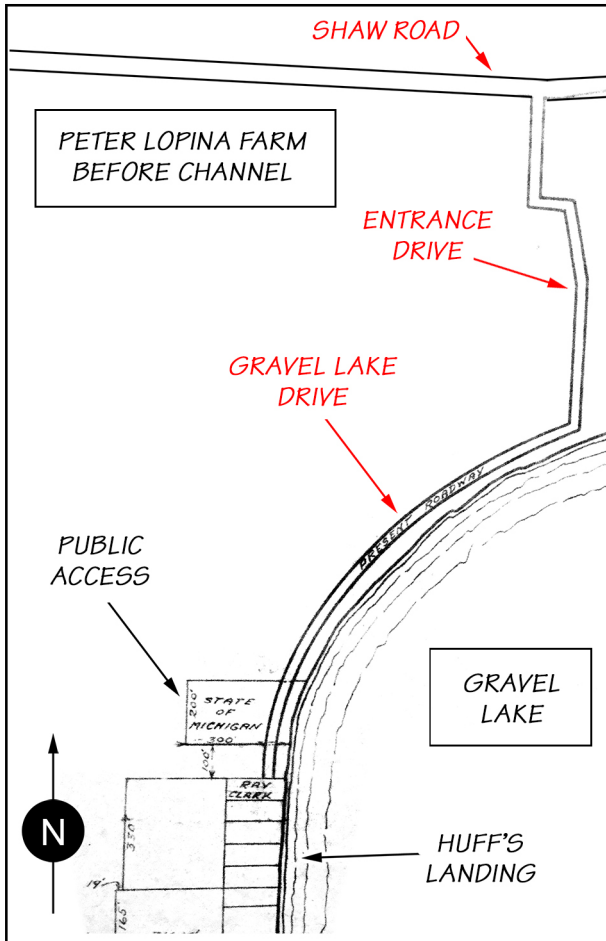

Origins of Huff's Landing

On March 2, 1839, Orsamus Bushnell of New York purchased 75.70 acres from the United States. It was described as, "The Northwest Fractional Quarter of Section 31, Town 4 South, Range 13 West". Today we refer to these 75.70 acres as Huff's Landing and Sandy Beach. Mr. Bushnell subsequently sold the 75+ acres to Horatio & Mary Lawrence in 1851. Then in 1857 the Lawrence's sold to Alvin & Fanny Taylor. There was a \$200 mortgage on the property at that time. From the mid-1800's to the late 1800's the parcel was bought and sold, or lost and foreclosed upon several times. Sometime in the late 1800's it appears the 75.70 acres began to be divided and cottages were constructed.



On April 30th of 1915 Otis & Irene Huff purchased a portion of the area known as Oak Bluff, later to be renamed "Huff's Landing". Mr. Huff was a local attorney in Marcellus. He was also owner and editor of the Marcellus newspaper. His daughter Elsie and her husband Bernard Kirk built their retirement home on a parcel in 1976, replacing an earlier cottage. Mr. Otis Huff eventually sold a north parcel to his friend Dr. Adams of Marcellus. Dr. Adams then sold or donated a portion of the parcel now known as the DNR Public Access. Today one of the other parcels purchased in the early 1900s by Nelson Christenson of Mishawaka, Indiana remains in the family and is now owned by Paul & Mary (Bukacek) Howell. They recently replaced the original cottage built in the very early 1900's. (Their beautiful home is a light blue color now. It used to be red on top and stone on the bottom).

Huff's Landing was eventually divided into lots with a private drive/deeded easement intersecting individual lots. Today there are 13 home parcels on Huff's Landing.

The remainder of the original 75.70 acres purchased by Orsamus Bushnell from the United States became Sandy Beach. The Sandy Beach channel was dug in 1952-1953, and developed by realtor LaVern Rice, creating many additional parcels for cottages. A January 10, 1941 survey shows all of Sandy Beach as the Peter Lapina farm with no channel or Gravel Lake Drive, and a road along the shoreline to Huff's Landing.

Poison Ivy

Fall has arrived! The cooler weather means the end of this year's lake season, but as we know, that doesn't mean the yard work stops. 'Tis the season for mowing, raking, weeding, and bonfires! One nasty little bugger to watch out for during the fall season is poison ivy. Whether you've heard of it, or suffered from it, you know what a pain it can be! But how much do you really know about our three-leafed foe?

First of all, we must identify the ivy leaves. "Leaves of three, let them be" is an easy way to remember. Poison ivy is green with one leaf in the center and two on the sides, and the leaves can be smooth or have toothy edges. Poison ivy lies low on the forest floor, it may crawl up on low bushes or shrubs, and it grows along walking paths. I have seen poison ivy on the path at the end of Huff's Landing, so be on the lookout!

Why does poison ivy itch so bad and cause a rash? There is an oil on the leaves, called urushiol oil, that causes your body to have an allergic response. The allergens in the oil create inflammation in the form of a red bumpy rash on your skin that can start showing up 24 hours or so after the contact with the plant. Even indirect contact with the plant, like petting your dog who has rolled around in ivy, can spread the rash to you. The rash may spread quickly on your body and become very itchy and uncomfortable. Inhaling the smoke of burning poison ivy can also be dangerous. Be careful what you are throwing in your fall bonfires! The smoke can cause itchy eyes, and it can even affect your lungs. If you think this has happened to you, seek medical attention quickly.

What do I do when I see poison ivy? The best advice is to steer clear and cover up. Cover your feet, legs, arms, hands, and anything that may be in contact with the leaves.

What if I do come in contact with poison ivy? Because the poison ivy rash might not show up for up to 72 hours after contact, you may not be able to take action right away. But if you are sure that your skin has been in contact with poison ivy, it is key to immediately wash the area with lukewarm, soapy water. Alcohol wipes will do if soap and water is not an option. Be sure to give anything that touched the poison ivy a wash-down as well. Rakes, hoses, garden tools, boots, gloves, animals, etc. must be washed to remove the oils. And don't worry, your pet may transfer the oils to you, but his/her fur is enough to keep the oils from creating a rash on your furry friend.

It's so itchy; What can I do to relieve the discomfort? Inflammatory symptoms, like itching, can be treated with steroids. Hydrocortisone is an easy-to-find, over-the-counter steroid that comes in familiar brand names like Cortizone 10 or Tecnu. These are topical agents that can be applied right to the rash to relieve those pesky symptoms.

So enjoy the beautiful fall foliage that Michigan offers, but be on the lookout for this mean, green leaf this fall!

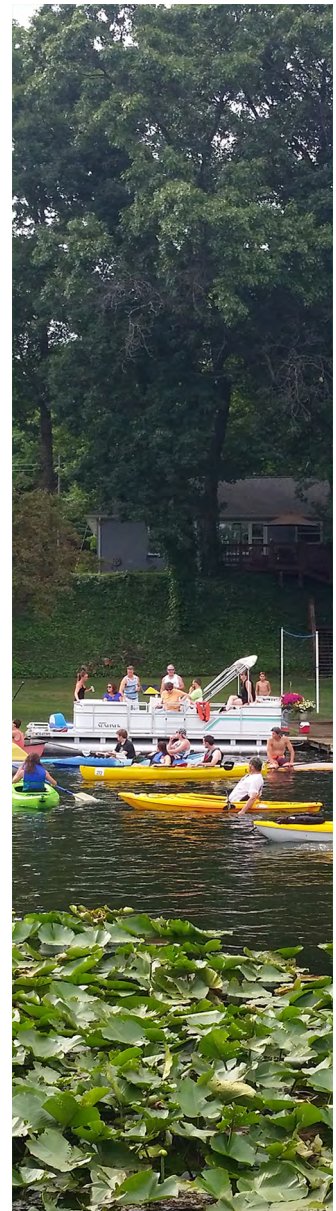
